## CHARTER TERMS AND CONDITIONS

- 1/ Tentative bookings will be held for a maximum of 7 days, unless there is another request for the same time slot and date then the booking must be confirmed with a deposit within 48 hours.
- 2/ A \$1,000 **deposit** will be required to confirm your tentative booking. A further security deposit may also be requested and refunded within 7 days after the cruise.
- 3/ Deposits will be refunded on request if the cruise is cancelled more than 60 days prior, less and administration fee of \$200. If cancelled within 60 days, a refund will be given **ONLY** if that time slot is rebooked. Charters cancelled within 7 days will be invoiced for the **FULL** cost of the cruise, less beverages.
- 5/ **The balance of the charter cost is payable 7 days 'in advance'**. Credit card payments will attract a surcharge. Any over payments will be credited within 7 days following the charter. Consumption bar tabs must be settled by company cheque or credit card prior to disembarkation.
- 6/ Extensions to cruises are usually available, subject to prior commitments, the appropriate boat-hire rate will be charged plus \$40/ hour for staff where applicable.
- 7/ In accordance with the NSW clubs and restaurants act smoking is only permitted in the dedicated smoking area of the vessel.
- 8/ In accordance with NSW Liquor Licensing Act, the Company practices responsible service of alcohol. Any persons deemed to be intoxicated will be refused service of alcoholic beverages.
- 9/ The Charterer acknowledges that during the charter period the vessel will remain under the complete control of the Captain and/or crew. If for any reasons of unruly or lewd behaviour, or for any weather, tidal or other reason the Captain considers it necessary to vary the length or route of the charter, his decision will be final.
